tb Minuteman is an intermediate level hard surface disinfectant as well as a tuberculocide, virucide and fungicide. tb Minuteman is designed for use in dental and medical clinics, hospitals and nursing homes where disinfection and prevention of cross-contamination is of prime importance. tb Minuteman is safe for use on non-porous environmental hard surfaces, such as counters, trays, tables, etc. tb Minuteman will not stain or leave residual smears after drying. tb Minuteman is not for use in hospital nurseries.

tb Minuteman provides complete tuberculocidal activity against:

To Pull Towelettes through the Lid,

1. Unscrew entire lid from the canister.
2. Remove the protective seal from the canister.
3. Pull up a corner of the first towelette from the centre of the roll and push 2 cm through the X in the lid.
4. Replace lid tightly on the canister.
5. Lift the flip-top and pull out the towelettes one at a time.

Directions for Use

Preclean the surface by wiping with a towelette to remove organic and other soils. Dispose of towelette. To disinfect the precleaned surface, apply tb Minuteman liberally, by wiping the surface with a towelette until the surface is thoroughly wet. Ensure the surface remains wet for at least 1 minute at Room Temperature. Then wipe the surface dry.

Once opened, the unused portion of the product may be stored in the original container for up to 60 days until used.

Precautions:

First Aid: If solution is swallowed, give a glass of water. If contact with eyes or skin occurs, flush thoroughly with water. For excessive inhalation, remove patient to fresh air. Get medical attention if ingested, if contact with eyes occurs or if an irritation persists.

Storage: Towelettes are saturated with flammable liquid. Keep away from heat, sparks and open flames. Store closed in original container at Room Temperature.

Disposal: Rinse the empty container. Do not reuse the empty container for alternate uses. Dispose of the container in accordance with municipal and provincial requirements.
